What We've Accomplished

- We last met with PGU Retirement Coordinators in May 2019 for our MPAS+ Workshops
 - We shared our improvement ideas with you
 - You gave use feedback and shared your own ideas
- Since that time, we have
 - Rolled out Version 1 of our new Customer Service system
 - Rolled out Version 1 of our new Document Management system
 - Rolled out Version 1 of the mySRPS Participant Portal
 - Reengineered how we process requests for benefit estimates



New Participant Portal: mySRPS

More features will be added in future versions as we complete process reengineering (like online enrollment, designate beneficiaries, refunds, retirement applications, etc.)

How to Register for mySRPS

- 1. We are mailing out registration packets to all SRA Participants
 - We mailed about 70,000 packets to all active members working for State agencies in February and March. We got almost 18,000 Participants to sign up.
 - Then COVID happened. We paused our rollout.
 - On May 26 we restarted our rollout. We're now sending registration packets to both active PGU members and retirees. We plan to finish the rollout to all active members by the middle of September. The rollout schedule for PGUs is posted at https://sra.maryland.gov/mpas-project.
- 2. Any Participant can request a registration packet on our Website at any time. Click mySRPS login and Register or go to mysrpsusers.sra.maryland.gov/GetEnrollment

Our New Estimate Process

- The new mySRPS benefit estimator is awesome!
 - Get an estimate 24x7 at any time during your career
 - Create assumptions for changes in salary and service, for military service, and for unused sick leave
 - Save and compare multiple versions
- Because we had the online estimate process done, we decided to finish the paper process before starting Employer Reengineering.
- We redesigned all forms and letters to make them easier to understand and use
- We streamlined and automated our paper process (still for members within 12 months of retirement)
 - "Easy" cases can be completed the same day without staff assistance
 - "Hard" cases should be completed in days, not weeks.



Employer Reengineering

- We have our initial plans in place and we're itching to get started. But we need to finish our Estimate Reengineering first.
- We are going to start Employer Reengineering (slowly) this month.
- We'll remind you of our "Big Ideas" from the workshops last year
- We captured and analyzed all of your feedback. Our plans have been modified based on your feedback.
- We still have LOTS of details to work out
- We will still include you in our design, development, and testing process to make sure we meet your needs



New Employer Portal

Basic Idea

Details

Will include:

- Employer User and Contact maintenance
- Document upload
- Document history
- Secure messaging
- Portal Dashboard (alerts, tasks, reminders)
- Online support tools
- New reports

Benefits

- Control access to Portal multiple users and roles
- Contact info up-to-date
- Convenient for providing required docs
- Record of docs sent/received
- Convenient and secure messages
- Easy task and deadline tracking
- Receive announcements
- Get online help
- Create custom reports

Version 1.0 will provide the current EPDR features, plus:

- Enhanced security
- You maintain users and roles
- Update your contact info
- Pay online
- View invoices & payments
- Secure Messages
- Secure file upload
- Document upload & history
- Create your own reports



Enhanced Payroll File & Validation

Basic Idea

SRA will be asking you to submit your data file in a different format, with more info.

Payroll data must pass validations to be accepted.

Details

SRA will:

- Define new CSV file with new data (e.g., link to pay schedule)
- Provide new file spec & technical workshops
- Perform all data validations after upload
- Send email when processing is complete
- Provide tools to resolve exceptions

- CSV file format is more flexible and easier to create
- Enhanced file & validation means:
 - Better data quality = faster and more accurate benefit calculations
 - Fewer errors = more time to help you
- You will know SRA validation rules
- Test files before processing
- Resolve errors in "real time"
- 24X7 convenience



Electronic Adjustments

Basic Idea

New ability for Employers to report electronic payroll adjustments

Details

Employers can:

- Provide employee pay record adjustments within the new payroll file as a new record type
- Indicate for each adjustment record what pay period it's for

- You can report adjustments electronically...no more paper
- No limit on the number or timing of adjustments
- You provide info on the lump sum and dates, and SRA will do all the math
- Positive and negative adjustments for hours, salary, and/or contributions are OK



Electronic Payments

Basic Idea

Portal calculates amount due and requests matching electronic payment

Details

- Calculates amount due based on approved payroll data file
- Employers pay using ACH debit; no more checks
- System will track the history of all invoices and payments

- No reconciliation between payroll data and payments
- Easy payment process
- No delays in posting member data
- View a history of all invoices and payments



Employee Roster File

Basic Idea

Submit Employee Roster File to SRA

Rapidly and reliably:

- Identify when employee status changes
- Confirm enrollment eligibility

Details

Content will include:

- Full Employee list
- Demographic info
- Key dates: birth / hire / termination / death / leave
- Standard hours
- Pay schedule
- Member contact info

- Promotes timely and uniform enrollment
- No paper enrollment or termination certification
- Better member contact info
- Streamlines Employees key processes
- Further automate SRA processes enrollment, death benefit, work after retirement, termination, and retirement = better service for employees



State Agencies

- Our goal is to create new processes and tools that work for both PGUs and State agencies
 - Common user experience
 - Better training and customer service
 - Easier and more cost effective to operate and maintain
- How will this work
 - We will figure out how to provide State Agency staff access to the new Employer Portal
 - We will figure out which tasks should remain centralized (like payroll file submission) and which tasks should be at the Agency level (like resolving reporting errors)
 - We will develop a testing and training program that includes all impacted State staff
 - We will include State staff in our new Employer Advisory Group
